- US LBM will continue efforts to reduce emissions to air, water and soil and greenhouse gas emissions.
- US LBM will continue its efforts to reduce waste and it will continue to focus on recycling efforts.
- US LBM will continue to investigate and set appropriate targets and goals for emissions, use of resources, and waste reduction.
- US LBM will monitor and report regularly on our environmental compliance and our sustainability efforts. This will be done via our sustainability report.
- US LBM will continue to promote the importance of environmental awareness to increase understanding about our environment and the importance of protecting it - within our company and our communities.

- Encourage suppliers to conduct their activities consistent with this policy via a Supplier Code of Conduct
